## **COOKIE NOTICE**

## 1. HOW WE USE COOKIES

When we use words like "us", "we", and "our," we mean Dropmeister Limited (hereinafter as "Company"). You can find our Company details listed in Section 7. We are Data Controllers of the data collected through the use of cookies on our website. Our website is <a href="https://lcft.com/">https://lcft.com/</a> and includes all sub-domains we own and operate. When we refer to "website" we mean <a href="https://lcft.com/">https://lcft.com/</a>. When we refer to "you" we mean you as a user or visitor of our site. #### 2. CONSENT

You previously consented to our use of cookies through the banner displayed on our website. This consent extends to all cookies except for strictly necessary cookies, as outlined in Section 6 'Types of Cookies and How We Use Them'.

#### 3. WHAT IS A COOKIE?

Cookies are small pieces of data that websites store on your device to enhance your browsing experience. They serve various purposes, including:

- Personalization: Remembering your preferences (e.g., language, theme) and tailoring content to your interests.
- Functionality: Enabling features like logins, shopping carts, and saved settings.
- Analytics: Tracking website usage to improve performance and identify trends.
- Advertising: Delivering targeted ads based on your browsing history.

Cookies can collect information about your device, browsing behaviour, and preferences. This data helps websites provide a more efficient and personalized experience.

# 4. SESSION COOKIES AND PERSISTENT COOKIES

Session cookies are cookies that last for a session. A session starts when you launch a website or web app and ends when you leave the website or close your browser window. Session cookies contain information that is stored in a temporary memory location which is deleted after the session ends. Unlike other cookies, session cookies are never stored on your device. Therefore, they are also known as transient cookies, non-persistent cookies, or temporary cookies. Typically, session cookies are used to remember what a user put in their basket when browsing a site.

Persistent cookies are cookies that remain on a user's device even after they close their browser. They have an expiration date and can be used to store information that can be accessed across multiple browsing sessions. This information can include login credentials, language preferences, and other customized settings.

#### 5. WHAT'S THE DIFFERENCE BETWEEN FIRST AND THIRD-PARTY COOKIES?

First-party cookies are cookies that are set by the site you are visiting and it's only this site that can access and read these cookies.

Third-party cookies are set by someone other than the owner of the site you're visiting. As an example, some pages have content from other sites like YouTube. YouTube may set its own cookies on your browser when you play the video from YouTube. Cookies set by other sites and companies (i.e., third parties) can be used to track you on other sites that use the same third-party service. We may engage third parties to assist with the maintenance, operation, creation, or functionality of our site, e.g., analytics providers and content partners. We grant these third parties access to selected information to perform specific tasks on our behalf.

We are, as a general rule, joint controllers with providers of third-party cookies for the collection of personal data via such cookies and disclosure details to that provider. The provider of third-party cookies is a data controller for the processing of the personal data that is received from us.

#### 6. TYPES OF COOKIES AND HOW WE USE THEM

## a. Necessary cookies

Some cookies are essential for the website's navigation, performance, security and functionality. These cookies are required in order to deliver information and services to you.

For example, necessary cookies are used to display content, allow you to log in to your account, etc. Without these cookies, some parts of our website cannot function properly. Please note that necessary cookies are essential and do not require consent.

## b. Preference cookies

Preference cookies allow our site to remember preferences, helping you to customize your experience on our site.

For example, preference cookies remember you when you return to our website, direct you to the homepage of your current location and provide you with live chat support if needed.

## c. Statistical cookies

Statistical cookies (also known as "performance improvers") help us understand how you use and interact with the website and allow us to make it better. These cookies do not use any personal data and provide us only with the aggregated data. In case we use Google Analytics cookies, not only we anonymize data which is collected but also we ensure the data sharing has been turned off and we do not use other Google services in combination with the Google Analytics cookies unless you have expressed your consent regarding use of marketing cookies.

For example, these cookies collect information about how visitors move around the website when they are using it, and help us to identify recurring errors that they may encounter. This allows us to provide necessary information for our users and to update the website according to their interests.

## d. Marketing cookies

Marketing cookies (also known as "advertising cookies") are used to deliver targeted content based on behavioural traits and measure the success of our marketing campaigns. These cookies are placed on the website by our third party service providers and they may remember your web browsing activity and actions across websites, as well as be used to analyse demographic information such as age and gender. Also, marketing cookies can be used to track the effectiveness of our ad campaigns on third party websites.

These cookies allow us, for example, to advertise our services for potential customers after they exit our website, serving these potential customers ads on other sites they visit later.
